We request that Action C is reworded a follows:

ACTION C: IDENTIFY NON-DESIGNATED HERITAGE ASSETS

Undertake a review of non-designated heritage assets (buildings **and parks and gardens** of heritage merit which are not nationally listed) and seek their addition to the West Berkshire Local List of Heritage Assets.

We suggest that the NDP group include these two assets in any emerging study to identify non-designated heritage assets in the area.
